



Summary of Regulated Child Care Facilities Licensed Facilities

In BC, any facility providing care to three or more children not related by blood, adoption or marriage is required by law to obtain a Community Care Facilities Licence. This is to ensure the health and safety of children.

NOTE: An LNR child care provider is an individual providing child care in his or her own home. The LNR child care provider may care for two children or one sibling group at any one time. This is in addition to their own children, children related to the child care provider by blood or marriage and foster children.

To register as an LNR provider with the CCRR, an LNR provider must:

- be at least nineteen years of age (proof of Identification: Driver's License, BC ID, Birth Certificate, Immigration Papers, and Passport).
- provide care for no more than 2 children not related by blood or marriage, with the exception of a sibling group as defined and applied in the Community Care and Assisted Living Act (CCALA). Persons who provide care and supervision to more than 2 children must be licensed under the CCALA. (See the Community Care and Assisted Living Act (CCALA) below.).
- receive a standardized Self Evaluation.

- complete an initial interview with the CCRR, completing the standardized *Child Care Provider Interview*.
- undergo criminal record check.
- ensure that a criminal record check is completed for everyone else in the home 12 years of age and older who is ordinarily present on the premises where the family child care is located.
- provide character references (at least 2) and a standardized *Character Reference* to be completed for each.
- produce a valid First Aid Certificate or proof of registration (approved by CCRR).
- undergo and complete a standardized *Health and Safety Home Assessment* prior to LNR registration.
- agree to inform the CCRR of any investigation of the care provider or other members of the household involving child abuse, neglect or significant risk to the health, safety or well being of children.
- complete, or have completed, at least twenty hours of family child care training (or equivalent education related to caring for children) before or within one year of becoming registered or within 2 years in exceptional circumstances (ESL course availability, rural area course availability).
- commit to and attend at least two workshops per year of continuing professional development after registration year.
- sign a standardized Commitment of Agreement and Consent.

¹ CCALA "Community Care Facility" means a premises or part of a premises (a) in which a person provides care to 3 or more persons who are not related by blood or marriage to the person and includes any other premises or part of a premises that, in the opinion of the medical health officer, is used in conjunction with the community care facility for the purpose of providing care.

It is recommended that parents check that chosen child care providers have adequate liability insurance.
